RESOLUTION NO. 454-2023

APPROVING RESOLUTION NO. 103-2023 OF THE SANGGUNANG BAYAN OF ROSALES, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PLAN NO. 01 CY 2023 INVOLVING AN AMOUNT OF TWENTY-NINE MILLION THREE HUNDRED FIFTY-FIVE THOUSAND EIGHTY-NINE PESOS AND TWENTY-EIGHT CENTAVOS (P29,355,089.28) FUNDED FROM RETAINED EARNINGS CY 2022 FOR PURPOSES OF FUNDING THE PROGRAMS IN VARIOUS OFFICES IN THE MUNICIPALITY OF ROSALES, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Rosales, Pangasinan submitted its SB Resolution No. 103-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of Rosales, Pangasinan had identified items in their Supplemental Investment Program (SIP) No.01 CY 2023. This was endorsed to the Sangguniang Bayan for approval on March 13, 2023 by the Municipal Development Council through Resolution No. 0313, S. 2023. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;

2. The Supplemental Investment Program No. 01 with a total investment requirement of Php29,355,089.28 covers fund augmentation for Maintenance and Other Operating Expenses of various offices in LGU Rosales and Capital Outlay for the Purchase of Solar Panel, Establishment of Slaughter House and Purchase of Handheld Radios at LDRRM Office of the LGU; and
3. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 01 CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01-2023 on March 28, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Rosales, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 103-2023 of the Sangguniang Bayan of Rosales, Pangasinan, entitled “Approving Supplemental Investment Plan No. 01 CY 2023 involving an amount of Twenty-Nine Million Three Hundred Fifty-Five Thousand Eighty-Nine Pesos and Twenty-Eight Centavos (P29,355,089.28) funded from retained earnings CY 2022 for purposes of funding the programs in various offices in the Municipality of Rosales, Pangasinan”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Rosales, Pangasinan, for its information and guidance.
