PROVINCIAL RESOLUTION NO. 458-2023

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH CYDEN MEDICALE TRADING, INC. FOR THE PROVISION OF HOSPITAL EQUIPMENT UNDER PUBLIC-PRIVATE PARTNERING SCHEME FOR THE FOURTEEN (14) PROVINCIAL GOVERNMENT HOSPITALS OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan has been gradually embarking on new programs and projects to greatly enhance the delivery of public health and medical services to the people;


