**PROVINCIAL RESOLUTION NO. 46-2023**

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE PHYSICIANS FOR PEACE PHILIPPINES AND THE URDANETA DISTRICT HOSPITAL FOR THE CONDUCT OF A JOINT 2-DAY SURGICAL MISSION IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, the Physicians for Peace Philippines is a registered non-government organization affiliated with the Physicians for Peace based in Norfolk, Virginia, USA which has been conducting medical missions in different parts of the country;

**WHEREAS**, the Provincial Government of Pangasinan, through the Urdaneta District Hospital, in partnership with the Physicians for Peace Philippines will join efforts in conducting a 2-day Surgical Mission on January 28 to 29, 2023;

**WHEREAS**, the Urdaneta District Hospital shall provide its health care facilities and equipment and a suitable area for the loading and unloading of equipment and medical supplies of the said medical team for the duration of the aforesaid medical mission;

**WHEREAS**, the duties and responsibilities of the parties are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;

**WHEREAS**, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign the Memorandum of Agreement to further augment the need for medical services of the Province;

Espinosa;
