OF HIS TEAM, ANYANG KOREA GINSENG CORPORATION (KGC),
IN THE 2022-2023 KOREAN BASKETBALL LEAGUE
CHAMPIONSHIP**

WHEREAS, with the continuous support given by the Provincial Government to athletes through different sports program, the Province of Pangasinan has produced outstanding athletes in various sporting events, one of whom is 25-year-old six-foot-two Rhenz Abando, a professional basketball player from Bactad East, Urdaneta City and a potential superstar cager;

WHEREAS, recently, Rhenz Abando concluded an unforgettable season by helping Anyang KGC reclaim the 2022-2023 Korean Basketball League crown as they ousted the Seoul SK Knights in a Game 7 overtime finish of their best-of-seven finals before collecting the championship;

WHEREAS, according to reports, Rhenz Abando, despite going scoreless in 27 minutes and 50 seconds of action, racked up 3 rebounds, 1 assist, 1 steal, and 2 blocks to help Anyang KGC dethrone Seoul SK Knights and reclaim the title it last won in the 2020-2021 season;

WHEREAS, the KBL crown, Mr. Abando's first professional basketball championship, capped off his rookie season with Anyang KGC as he had also won the KBL Slam Dunk contest, 3-on-3 All-Star Game, East Asia Super League (EASL) title, and the KBL regular season championship;


