**DECLARING ORDINANCE NO. 05-2022 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 20 OF THE MUNICIPAL ORDINANCE NO. 7-2019, ENTITLED: "AN ORDINANCE STRENGTHENING THE PRE-MARRIAGE ORIENTATION AND COUNSELLING (PMOC) PROGRAM OF THE MUNICIPALITY OF ANDA, PANGASINAN, THROUGH THE ADOPTION AND IMPLEMENTATION OF THE DILG, DOH, DSWD, POPCOM AND PSA JOINT MEMORANDUM CIRCULAR NO. 21 SERIES OF 2018" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 05-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 447 (a) (1) of R.A. No. 7160; Sections 12 Article II and Section 1 Article XV of the 1987 Constitution; Joint Memorandum Circular (JMC) No. 1, Series of 2018 of the DILG, DOH, DSWD, POPCOM; and DILG Memorandum Circular No. 2018-182 dated October 26, 2018;




