PROVINCIAL RESOLUTION NO. 470-2023

**RECOGNIZING THE PANGASINAN CIVIL SOCIETY
ORGANIZATION NETWORK AS THE PROVINCIAL PEOPLE'S
COUNCIL OF THE PROVINCE OF PANGASINAN**

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non- governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083 on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

WHEREAS, the Department of the Interior Local Government also issued Memorandum Circular 2021-054 mandating LGUs to create a Civil Society Organization Desk and to create and institutionalize a People Council which shall be composed of representatives from Civil Society Organizations (CSOs) authorized by the LGU;

WHEREAS, based on the 2 memorandum circulars stated above, on September 14, 2022, the Provincial Government of Pangasinan called for the CSO Conference cum Assembly of all 122 Accredited CSOs of the province and attended by 192 CSO members in the Province. They had their set of officers and agreed upon to be named as Pangasinan CSO Network;

WHEREAS, the elected CSO Network which comprises of 14 various sectors of the community have actively participated in the planning, implementation, monitoring and evaluation of the province's programs, projects and activities;
