RESOLUTION NO. 473-2023

DECLARING ORDINANCE NO. 2023-09 OF THE SANGGUNANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE RENAMING THE SPORTS DEVELOPMENT OFFICE TO YOUTH AND SPORTS DEVELOPMENT OFFICE, RETITLING THE POSITION OF SPORTS DEVELOPMENT OFFICER 1 TO YOUTH DEVELOPMENT OFFICER 1 WITH THE SAME SALARY GRADE AND QUALIFICATION STANDARDS, THEREBY AMENDING SECTION I AND II (A) OF ORDINANCE NO. 2021-26, KNOWN AS AN ORDINANCE CREATING THE CITY SPORTS DEVELOPMENT OFFICE IN THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-09 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Rule XII of the Implementing Rules and Regulations and Sections 76 & 447 (a) (1) (viii) of R. A. No. 7160;


