RESOLUTION NO. 474-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-01 OF THE SANGGUNANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AN ORDINANCE RETITLING THE PLANTILLA POSITION OF LEGISLATIVE ASSISTANT 1 – SG 11 TO LOCAL LEGISLATIVE STAFF OFFICER 1 – SG 11 UNDER THE SANGGUNANG BAYAN’S OFFICE, THEREBY AMENDING SECTION 2 (H) OF MUNICIPAL ORDINANCE NO. 2005-04 WHICH CREATED THE FORMER PLANTILLA POSITION” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2023-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;




