RESOLUTION NO. 475-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-03 OF THE SANGGUNIAN BAYAN OF BUGALLON, PANGASINAN, ENTITLED “AN ORDINANCE INCREASING THE SALARY GRADE FOR THE PLANTILLA POSITION OF ENVIRONMENTAL MANAGEMENT SPECIALIST II, UNDER THE MAYOR’S OFFICE, FROM SALARY GRADE 11 TO SALARY GRADE 15, THEREBY AMENDING SECTION 4 SUBPARAGRAPH 4 OF MUNICIPAL ORDINANCE NO. 2021-07 WHICH CREATED THE SAID PLANTILLA POSITION” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Municipal Ordinance No. 2023-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in compliance with the Local Budget Circular No. 137 dated July 13, 2022 entitled “Index of Occupational Services, Position Titles and Salary Grades for Local Government (IOS-LGU) Calendar Year 2021 Edition”;


