DECLARING ORDINANCE NO. 06-2022 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 7 OF THE MUNICIPAL ORDINANCE NO. 06-2018, ENTITLED: AN ORDINANCE ESTABLISHING AND ADOPTING SET OF MEASURES AND SYSTEMS SUPPORTING MATERNAL NEONATAL AND CHILD HEALTH AND NUTRITION (MNCHN) STRATEGY OF THE MUNICIPAL HEALTH UNIT OF ANDA" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 06-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with the Department of Health Administrative Order 2008-0029, otherwise known as "Implementing Health Reforms for Rapid Reduction of Maternal and Neonatal Mortality and Sections 17 (a), (b) (2) (iii) and 447 (a) (2) (i) of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of posting pursuant to Section 59 (b) of RA 7160;
