RESOLUTION NO. 481-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-03 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “AN ORDINANCE ENACTING THE GENDER AND DEVELOPMENT CODE OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2023-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with national policies and principles of the Gender and Development Code of the Philippines, enshrined in the 1987 Philippine Constitution, Gender and Development Code of the Province of Pangasinan, Republic Act No. 7192 (An Act Promoting the Integration of Woman as Full and Equal Partners of Men in Development and Nation Building and for other purposes) and Sections 16 and 17 (a) and (iv) of R. A. No. 7160;;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


