NO. 01-2022 OF THE ORDINANCE DECLARING SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE INCREASING ENVIRONMENTAL FEE FOR TOURISTS, TRAVELERS AND GUESTS, AMENDING SECTIONS 1 AND 2, CHAPTER XI FOR THE PURPOSE, MUNICIPAL ENTITLED **"ORDINANCE** S-2017, ORDINANCE NO. 1, OF THE THE TOURISM CODE ESTABLISHING MUNICIPALITY OF DASOL, PANGASINAN" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Ordinance No. 01-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting, public hearing, and publication set forth in Sections 59 (c), 187 and 188 of RA 7160;
