RESOLUTION NO. 49-2023

DECLARING ORDINANCE NO. 01-2022 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE INCREASING ENVIRONMENTAL FEE FOR TOURISTS, TRAVELERS AND GUESTS, AMENDING SECTIONS 1 AND 2, CHAPTER XI FOR THE PURPOSE, MUNICIPAL ORDINANCE NO. 1, S-2017, ENTITLED "ORDINANCE ESTABLISHING THE TOURISM CODE OF THE MUNICIPALITY OF DASOL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Ordinance No. 01-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 186 of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting, public hearing, and publication set forth in Sections 59 (c), 187 and 188 of RA 7160;


