**RESOLUTION NO. 493-2023**

**DECLARING MUNICIPAL ORDINANCE NO. 2, S-2023 OF THE SANGGUNIAN BAYAN OF BINMALEY, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE PERSONS WITH DISABILITY AFFAIRS OFFICE IN THE MUNICIPALITY OF BINMALEY AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Ordinance No. 2, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iv), 443 (c) (2), 447 (a) (5) (xiv) of R. A. No. 7160, Republic Act No. 7277, otherwise known as the “Magna Carta for Disabled Persons, Section 4 of the Implementing Rules and Regulations of Republic Act No. 10754 “An Act Expanding the Benefits and Privileges of Persons with Disability (PWD), Republic Act No. 10070 “Establishing Institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City and Municipality, Amending Republic Act No. 7277, Otherwise Known as the Magna Carta for Disabled Persons, as Amended, and for Other Purposes” and Convention on the Rights of Persons with Disabilities;

**WHEREAS**, it is now incumbent on the part of the Local Chief Executive in coordination with the Municipal Local Finance Committee to prepare a Supplemental Budget/Appropriation to finance the implementation of the subject ordinance;
