RESOLUTION NO. 497-2023

APPROVING RESOLUTION NO. 43, S-2023 OF THE SANGGUNANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) (FUNDED BY THE 20% INTERNAL REVENUE ALLOTMENT AND OTHER SOURCES) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2023"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 43, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program for CY 2023. This was endorsed by the Council, through MDC Resolution No. 02, Series of 2023 dated March 2, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Annual Investment Program, has a total investment requirement of ₱207,631,507.73. Of this, the sum of ₱43,131,507.73 will be funded from the General Fund of the LGU as embodied in the LGU's Supplemental Budget No. 1, CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, Series of 2023 dated April 3, 2023.

The remaining P150,000,000.00 will be sourced from the loan proceeds of the LGU and the P14,500,000.00 from the Department of Health thru HFEP; and

3. The project proposed for funding from the 20% Development Fund, in the amount of P11,163,761.00, conforms with the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Calasiao, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 43, S-2023 of the Sangguniang Bayan of Calasiao, Pangasinan, entitled “Approving the Supplemental Annual Investment Program (SAIP) (Funded by the 20% Internal Revenue Allotment and Other Sources) of the Municipality of Calasiao for the Year 2023”
