PROVINCIAL RESOLUTION NO. 5-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN THE MEMORANDA OF AGREEMENT BETWEEN AND AMONG THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT I, REGION I MEDICAL CENTER, DASOL COMMUNITY HOSPITAL, BOLINAO COMMUNITY HOSPITAL, DR. RUVINA A. BREGUERA AND DR. REED C. MOLINA FOR THE IMPLEMENTATION OF THE POST-RESIDENCY DEPLOYMENT PROGRAM IN THE PROVINCE OF PANGASINAN, SUBJECT TO THE COMMENTS OF THE PROVINCIAL LEGAL OFFICER

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the functional responsibilities for the delivery of basic health services and other related facilities have been transferred from the Department of Health (DOH) to the local government units;

WHEREAS, Executive Order No. 102 mandates the DOH to provide assistance to local government units in effectively implementing programs, projects and services for the provision of health care services to every Filipino;

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act of 2019, provides that the DOH shall deploy health care workforce under the National Health Workforce Support System to augment human resource needs in public health systems;

WHEREAS, the Region I Medical Center is an apex hospital for the Universal Health Care which can provide specialized Medical Doctors to the Province of Pangasinan to augment its medical human resource requirement;

WHEREAS, Dr. Ruvina A. Breguera and Dr. Reed C. Molina are Post-Resident Physicians of Region I Medical Center who specialize in Internal Medicine deployed at Dasol Community Hospital and Bolinao Community Hospital, respectively;

NOW THEREFORE, on motion of SP Members Shiela Marie F. Baniqued and Jerry Agerico B. Rosario, duly seconded, it was -


