DECLARING ORDINANCE NO. 2023-018 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING ORDINANCE NO. 2022-006, SERIES OF 2022, UNDER SECTION II-DUTIES AND FUNCTIONS OF ONE (1) ADMINISTRATIVE AIDE III-SG-3, UNDER THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO) AND ONE (1) ADMINISTRATIVE AIDE III-SG-3, UNDER THE LOCAL ECONOMIC ENTERPRISE/MARKET OFFICE, THIS MUNICIPALITY" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


