DECLARING ORDINANCE NO. 2023-020 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, REPRESENTED BY THE MUNICIPAL MAYOR, HONORABLE CARLITO S. ZAPLAN, AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, CESAR N. ULPINDO, IN THE AMOUNT NOT EXCEEDING ONE HUNDRED MILLION PESOS (P100,000,000.00) TO FUND THE LAND SITE ACQUISITION, LAND SITE DEVELOPMENT AND THE CONSTRUCTION OF TWO (2) STOREY COMMUNITY HOSPITAL LEVEL I AT BARANGAY POBLACION NORTE, STA. BARBARA, PANGASINAN INCLUDED IN THE APPROVED ANNUAL/SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2023" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2023-020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;




RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-020 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipality of Sta. Barbara, Pangasinan, represented by the Municipal Mayor, Honorable Carlito S. Zaplan, and the Land Bank of the Philippines, represented by its Assistant Vice President/Head, Pangasinan Lending Center, Cesar N. Ulpindo, in the amount not exceeding One Hundred Million Pesos (P100,000,000.00) to fund the land site acquisition, land site development and the construction of two (2) Storey Community Hospital Level I at Barangay Poblacion Norte, Sta. Barbara, Pangasinan included in the approved Annual/Supplemental Investment Program for Calendar Year 2023” as within the conferred powers of the Sangguniang Bayan to enact;
