RESOLUTION NO. 506-2023

DECLARING ORDINANCE NO. 6, S-2022 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING THE MUNICIPALITY COMPREHENSIVE NUTRITION PROGRAM THROUGH INTEGRATED STRENGTHENED, AND SUSTAIN STRATEGIES TO SAFEGUARD THE NUTRITIONAL WELL-BEING OF THE PEOPLE OF ASINGAN, PANGASINAN APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 6, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Provincial Health Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (a) (b) (2) (iii) of R. A. No. 7160, Department of Health (DOH) Administrative Order Nos. 2008-0029 and 2010-0036 and Republic Act No. 11148, otherwise known as the “Kalusugan at Nutrisyon ng Mag-Nanay Act;
