**RESOLUTION NO. 507-2023**

**DECLARING ORDINANCE NO. 184, S-2022 OF THE SANGGUNANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE HOLDING OF INTER-BARANGAY BASKETBALL AND VOLLEYBALL TOURNAMENTS (MAYOR'S CUP) ANNUALLY IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 184, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 of R. A. No. 7160, Article II Sections 13 & 17, and Article XIV Section 17 of the 1987 Philippine Constitution; and Republic Act No. 6847, otherwise known as the Philippine Sports Commission Act;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the legal requirement of posting pursuant to Section 59 (a) of RA 7160;




