### RESOLUTION NO. 508-2023

**DECLARING ORDINANCE NO. 196, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE GRANTING OF EMERGENCY SHELTER ASSISTANCE (ESA) TO ASSIST FAMILY VICTIMS OF DISASTER TO ACQUIRE DECENT SHELTER IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 196, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iv), 447 (a) (1) (iv) (5) (xiv) of R. A. No. 7160 and the Department of Social Welfare and Development Administrative Order No. 17, Series of 2010 or the Omnibus Guidelines on Shelter Assistance;

**WHEREAS**, the LGU shall prepare a supplemental appropriation (Supplemental Budget) to fund the implementation of the subject ordinance;




