DECLARING ORDINANCE NO. 04-2023 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE DISASTER RISK **REDUCTION AND MANAGEMENT OFFICE (MDRRMO) OF** SUAL, PANGASINAN, PROVIDING ITS COMPOSITION, FUNCTIONS, AND BUDGETARY REQUIREMENTS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 04-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76, 443 (c) (2) & 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the legal requirement of posting pursuant to Section 59 of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
