## **PROVINCIAL RESOLUTION NO. 513-2023**

#### AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL MAPPING AND RESOURCE INFORMATION AUTHORITY (NAMRIA) FOR THE ESTABLISHMENT OF AN ACTIVE GEODETIC STATION (AGS) ON THE ROOF DECK OF THE PANGASINAN PROVINCIAL ENGINEERING OFFICE

WHEREAS, the National Mapping and Resource Information Authority (NAMRIA) is the national government's central mapping agency which is responsible for the establishment of a nationwide geodetic network of control points that serves as common reference system for all surveys in the country;

WHEREAS, NAMRIA will set up an active geodetic station or global navigation satellite system (GNSS) reference stations for the Philippine Active Geodetic Network (PAGeNet) in the Province of Pangasinan;

WHEREAS, PAGeNeT gathers geographic positions from the GNSS for use in surveying, mapping, and other geodesic activities;

WHEREAS, the active geodetic station would provide more accurate and reliable information that the Province of Pangasinan can use in mapping, geographic information system and other related activities;

WHEREAS, the roof deck of the Provincial Engineering Office building has been found to be a suitable site for the operation of an active geodetic station;

WHEREAS, the Province of Pangasinan is willing to forge a Memorandum of Agreement with NAMRIA to host an active geodetic station and allow its continuous operation at the chosen site;

> WHEREAS, in regard to the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and NAMRIA, represented by Usec. Peter N. Tiangco, Administrator;

> WHEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was -

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the National Mapping and Resource Information Authority (NAMRIA) for the establishment of an Active Geodetic Station (AGS) on the roof deck of the Pangasinan Provincial Engineering Office;
