PROVINCIAL RESOLUTION NO. 514-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AGREEMENT BETWEEN AND AMONG VARIOUS EDUCATIONAL INSTITUTIONS FOR THE IMPLEMENTATION OF LEARNERSHIP AND ON-THE-JOB TRAINING PROGRAM FOR STUDENTS

WHEREAS, the Philippine Education Program implemented through the Department of Education for Elementary to Senior High School and Commission on Higher Education for Colleges and Universities aims to develop learners' competencies, work ethics and values relevant to pursuing further education and/or joining the world of work by allowing the learners to bridge the theories and concepts they were taught in school with the realities in workplace through work immersion or on-the-job training;

WHEREAS, various educational institutions in the Province of Pangasinan has instituted Internships/Work Immersion/On-the-Job Training Program where qualified students will undergo training prior to graduation in order for them to be adequately equipped with actual experience that will augment their formal training;

WHEREAS, educational institutions include Senior High Schools, Trade Schools, State Universities, and Public and Private Colleges within the country;

WHEREAS, these learning institutions propose that its students be allowed to undergo Internship/Work Immersion/On-the-Job Training Program at the Provincial Government of Pangasinan, subject to terms and conditions stipulated in the Memorandum of Agreement;

WHEREAS, Memorandum of Agreement provided by the educational institutions shall be subject to usual legal procedures prior to endorsement to the Local Chief Executive for his signature;

WHEREAS, the Provincial Government of Pangasinan (PGP) recognizes that one of its Community Social Responsibility is to create a positive impact in community capability building, especially the young people;

WHEREAS, one of the ways to do this is to provide a work immersion/on-the-job training environment that is informative, beneficial and establish creative thinking for students;

WHEREAS, work immersion for students/on-the-job trainees could serve as steady pool of applicants specially for hard to fill positions;

WHEREAS, this resolution shall cover both pending and prospective Memoranda of Agreement;

WHEREAS, this provincial resolution shall authorize the Governor to enter into agreement to all educational institutions proposing internship/on-the-job training of their students to the Provincial Government of Pangasinan and shall take effect from June 2023 until June 30, 2025;

WHEREFORE, in view of the foregoing, on motion of Vice Governor Mark Ronald DG. Lambino, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session duly assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into agreement between and among various educational institutions for the implementation of learnership and on-the-job training program to enhance the skills of students;

RESOLVED, FINALLY, that copies of this resolution be furnished to Honorable Governor Ramon V. Guico III, Province of Pangasinan, and the Human Resource Management and Development Office, for their information and guidance.
