PROVINCIAL RESOLUTION NO. 523-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE 1 FOR THE USE OF BUILDING AND LOT OWNED BY THE PROVINCE AS SITE FOR DSWD FIELD OFFICE 1 SATELLITE OFFICE OF PANGASINAN

WHEREAS, Section 465 of the Local Government Code of 1991 specifically provides that the governor shall represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan;

WHEREAS, the Department of Social Welfare and Development Field Office 1 has requested the Province of Pangasinan to occupy two (2) rooms of the Multi-Sectoral Building of the Provincial Social Welfare and Development Office to be used exclusively as DSWD Field Office 1 Satellite Office of Pangasinan;

WHEREAS, acknowledging the mandate of DSWD to develop, administer and implement comprehensive social welfare programs designed to uplift the living conditions and empower the disadvantaged children, youth, women, older persons, person with disabilities, families in crisis or at-risk and communities needing assistance, the Province of Pangasinan hereby agrees to allow the use of the aforementioned property and other facilities of the Multi-Sectoral Building free of charge, subject to the terms and conditions of the Memorandum of Agreement;

WHEREAS, the DSWD Field Office 1 is willing to shoulder the necessary expenses for the repair and maintenance of the premises during the term of the said Agreement;

WHEREAS, the period of use of the said property is from March 29 to December 31, 2023, subject to renewal upon mutual agreement of the parties;

WHEREAS, this Agreement will serve as a vehicle for collaboration efforts between the Province of Pangasinan and the DSWD Field Office 1 to further boost the social welfare services and development in the Province;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Honorable Governor Ramon V. Guico III, and the Department of Social Welfare and Development Field Office 1, represented by Regional Director Marie Angela S. Gopalan;

WHEREFORE, in view of the foregoing, on motion of SP Member Rosary Gracia P. Perez-Tababa, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development Field Office 1 for the use of building and lot owned by the Province as site for DSWD Field Office 1 Satellite Office of Pangasinan;
