RESOLUTION NO. 529-2023

DECLARING ORDINANCE NO. 2022-14 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE GRANTING BIRTHDAY CASH GIFT AND ADDITIONAL CENTENARIAN INCENTIVES TO QUALIFIED SENIOR CITIZENS IN THE CITY OF ALAMINOS, PANGASINAN AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2022-14 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010; Sections 17 (b) (2) (iv) and 458 (a) (5) and (xvii) of R. A. No. 7160 and Republic Act No. 10868, otherwise known as “An Act Honoring and Granting Additional Benefits and Privileges to Filipino Centenarians, and other Purposes”;
