**RESOLUTION NO. 53-2023**

**DECLARING ORDINANCE NO. 34, S-2022 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN ENTITLED “AN ORDINANCE ESTABLISHING THE AGUILAR SCHOLARSHIP/EDUCATIONAL ASSISTANCE PROGRAM TO UNDERPRIVILEGED BUT DESERVING AGUILAREÑO STUDENTS AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Ordinance No. 34, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (5) (xi) of R.A. No. 7160; 1987 Philippine Constitution; Republic Act No. 109311 otherwise known as “Universal Access to Quality Tertiary Education Act; Republic Act No. 10648 entitled: An Act Providing Scholarship Grants To Top Graduates of All Public High Schools in State Universities and Colleges and Appropriating Funds Therefor;


