RESOLUTION NO. 532-2023

DECLARING ORDINANCE NO. 2023-13 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE ABOLISHING THE FOLLOWING VACANT POSITIONS UNDER THE OFFICE OF THE CITY ACCOUNTANT: ADMINISTRATIVE OFFICER V (ACCOUNTING III), SG-19/1; ADMINISTRATIVE AIDE VI (ACCOUNTING CLERK II), SG-6/1 AND ADMINISTRATIVE ASSISTANT I, SG-8/1, AND CREATING THE FOLLOWING POSITIONS UNDER THE SAME OFFICE: SUPERVISING ADMINISTRATIVE OFFICER (RECORDS OFFICER IV), SG-22/1 AND ADMINISTRATIVE OFFICER II (MANAGEMENT AND AUDIT ANALYST I), SG-11/1; AND CHANGING THE POSITION TITLE OF ADMINISTRATIVE AIDE III (DRIVER I), SG-3/1 TO ADMINISTRATIVE AIDE III (AUDIO VISUAL EQUIPMENT OPERATOR) SG-3/1 UNDER THE CITY BUDGET OFFICE OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-13 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Rule XII of the Implementing Rules and Regulations and Sections 76 & 458 (a) (1) (viii) of R. 


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2023-13 of the Sangguniang Panlungsod of Alaminos, Pangasinan, entitled “An Ordinance abolishing the following vacant positions under the Office of the City Accountant: Administrative Officer V (Accounting III), SG-19/1; Administrative Aide VI (Accounting Clerk II), SG-6/1 and Administrative Assistant I, SG-8/1, and creating the following positions under the same office: Supervising Administrative Officer (Records Officer IV), SG-22/1 and Administrative Officer II (Management and Audit Analyst I), SG-11/1; and changing the position title of Administrative Aide III (Driver I), SG-3/1 to Administrative Aide III (Audio Visual Equipment Operator) SG-3/1 under the City Budget Office of the Local Government Unit of the City of Alaminos, Pangasinan” as within the conferred powers of the Sangguniang Panlungsod to enact;
