## **RESOLUTION NO. 536-2023**

## DECLARING MUNICIPAL ORDINANCE NO. 37, S-2023 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING AN EARLY CHILDHOOD DEVELOPMENT INTERVENTION PACKAGE FOR THE FIRST ONE THOUSAND (1000) DAYS OF A CHILD IN THE MUNICIPALITY OF AGUILAR, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Municipal Ordinance No. 37, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A. No. 7160 and Section 2 of Republic Act No. 8980 known as "Early Childhood Care and Development);
