APPROVING RESOLUTION NO. 159-04242023 OF THE SANGGUNIAN BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE FIRST (1ST) SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2023 TO BE FUNDED BY UNAPPROPRIATED SURPLUS/SAVINGS AND REVERSION OF APPROPRIATIONS OF UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 159-04242023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Pozorrubio, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 1, Series of 2023. This was endorsed to the Sangguniang Bayan for approval on March 28, 2023 by the Municipal Development Council-Executive Committee thru Resolution No. 01, Series of 2023;

2. Said SAIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses of various municipal offices and implementation of development projects and disaster risk reduction programs of the LGU; and
3. Funding support for the implementation of the same in the amount of Php67,519,219.81 is embodied in their proposed Supplemental Budget No. 1 for Fiscal Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 01-04242023 on April 24, 2023 and approved by the Municipal Mayor on April 27, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 159-04242023 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled “Approving the First (1st) Supplemental Annual Investment Program for CY 2023 to be Funded by Unappropriated Surplus/Savings and Reversion of Appropriations of Unfilled Positions of Pozorrubio, Pangasinan”;
