PROVINCIAL RESOLUTION NO. 546-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE LOCAL GOVERNMENT UNIT OF STA. MARIA AND THE EASTERN PANGASINAN DISTRICT HOSPITAL FOR THE ADOPTION OF REFERRAL SYSTEM ON MATERNAL AND NEONATAL SERVICES

WHEREAS, the 1987 Constitution ensures the protection and promotion of the right of the people to health and guarantees the availability of essential health services to all the people at affordable cost through various plans and programs;

WHEREAS, the Eastern Pangasinan District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 6th District of Pangasinan;

WHEREAS, the Eastern Pangasinan District Hospital is a PhilHealth accredited Referral Hospital that can respond and provide services to the Rural Health Unit (RHU) Sta. Maria Lying-in Clinic for the adoption of referral system in terms of maternal and neonatal services;

WHEREAS, the adoption of referral system on maternal and neonatal services is an important local health program in providing appropriate needed care to both the mother and newborn, and in reducing if not finally eliminating, maternal and infant mortality in the Province;

WHEREAS, the program is in consonance to RA 11223 or the Universal Health Care Act of 2019 which mandates the implementation of health reform program in order to ensure that every Filipino is guaranteed an equitable access to quality and affordable healthcare services and is protected against financial risks;

WHEREAS, it is also in conformity with Section 13 of the 1987 Constitution which provides that local government units may group themselves, consolidate or coordinate their efforts, services, and resources for purposes commonly beneficial to them in accordance to the law;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Local Government Unit of Sta. Maria, Pangasinan, represented by Municipal Mayor Julius C. Ramos;

WHEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) between the Local Government Unit of Sta. Maria and the Eastern Pangasinan District Hospital for the adoption of referral system on maternal and neonatal services;

RESOLVED FINALLY, that copies of this resolution be furnished to the Provincial Governor, Ramon V. Guico III, Province of Pangasinan, and Municipal Mayor Julius C. Ramos, Sta. Maria, Pangasinan, and other concerned authorities, for their information and guidance.
