APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2023

WHEREAS, presented for consideration is the Supplemental Investment Program No. 3 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Resolution No. 01, S-2023;

WHEREAS, Supplemental Investment Program No. 3 contains other priority programs, projects and activities that are not included in the approved 2023 Annual Investment Program of the Province of Pangasinan;

WHEREAS, the Supplemental Investment Program covers fund augmentation for Office Supplies Expenses, Maintenance and Other Operating Expenses of provincial offices and hospitals as well as implementation of priority programs and projects of the province under other Special Purpose Appropriations;

WHEREAS, the said Supplemental Investment Program likewise covers the Construction of Barn and Purchase of Vehicles and the proposed reprogramming of Department of Energy/Energy Regulations 1-94 projects from SIP No. 3 CY 2022 due to changes in the Annual Work Program (AWP);

WHEREAS, also included are additional infrastructure projects proposed to be funded from current and continuing appropriations;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;
