PROVINCIAL RESOLUTION NO. 550-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE OUR LADY OF LOURDES HOSPITAL, THE MUNICIPALITY OF TAYUG AND THE EASTERN PANGASINAN DISTRICT HOSPITAL FOR THE CONDUCT OF A JOINT 3-DAY FREE SURGICAL MISSION

WHEREAS, the Our Lady of Lourdes Hospital is a private non-profit tertiary hospital with a 230-bed capacity located in Santa Mesa, Manila which has been conducting community outreach programs;

WHEREAS, to celebrate the Our Lady of Lourdes Hospital's 75th Foundation Anniversary for this year, it will conduct a series of medical and surgical missions in identified provinces of the country to include the Province of Pangasinan;

WHEREAS, the Provincial Government of Pangasinan, through the Eastern Pangasinan District Hospital, in partnership with the Our Lady of Lourdes Hospital and the Local Government Unit of Tayug, Pangasinan will join efforts in conducting a 3-day free surgical mission from June 30 to July 2, 2023;

WHEREAS, the duties and responsibilities of every party in the conduct of the free surgical mission are already defined in the MOA;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to authorize the Provincial Governor to sign the Memorandum of Agreement to further augment the need for medical services of the Province;

NOW, THEREFORE, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


