WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its SB Resolution No. 069-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Agno, Pangasinan has identified items in their Supplemental Investment Program (SIP) No.1 CY 2023. This was endorsed to the Sangguniang Bayan for approval on April 20, 2023 by the Municipal Development Council – Executive Committee thru Resolution No. 01-2023;
- Said SIP covers fund augmentation for Personal Services (adjustment of salaries and wages, and other personnel benefits) and Purchase of Lot of the Municipal Government; and

Funding support for the implementation of the same in the amount of PhP3,088,025.00 is embodied in their proposed Supplemental Budget No. 1 for Calendar Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2023-01 on May 2, 2023 and approved by the Municipal Mayor on May 8, 2023.
