DECLARING ORDINANCE NO. 02, S-2022 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING REASONABLE OCCUPANCY FEE AMENDING SECTION 1, 3, 5, ARTICLE V AND REPEALING SECTION 1, 2 (a) (b) (c) ARTICLE VIII FOR THE PURPOSE, MUNICIPAL ORDINANCE NO. 02, S-2014 "AN ORDINANCE ESTABLISHING A NEW PUBLIC CEMETERY IN BARANGAY POBLACION, DASOL, PANGASINAN AND PRESCRIBING THE RULES AND REGULATIONS FOR ITS USE, OPERATION AND ADMINISTRATION, INCLUDING FEES, IMPOSITION OF PENALTIES AND INDIGENT BURIAL PROGRAM" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

A. No. 17160;
