**RESOLUTION NO. 556-2023**

**DECLARING ORDINANCE NO. 191, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO PERSON UNDERGOING HEMODIALYSIS OR PERITONEAL DIALYSIS WITHIN THE MUNICIPALITY OF BASISTA AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 191, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iii) & 447 (a) (5) (xiv) of R. A. No. 7160; and Section 15, Article II and Section 11, Article XIII of the 1987 Constitution;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 of R. A. No. 7160;
