### RESOLUTION NO. 557-2023

**APPROVING RESOLUTION NO. 373, S-2023 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1, CY 2023 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Lingayen, Pangasinan submitted its SB Resolution No. 373, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Lingayen, Pangasinan prepared their Supplemental Investment Program (SIP) No. 1 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 01, Series of 2023 dated April 13, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱72,521,144.70, covers the augmentation of funds for Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal offices, and the implementation of LDRRM programs and development projects of the LGU;

3. The proposed project to be funded from the 20% Development Fund amounting to P62,521,144.70, are based on Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

Likewise, the identified projects to be financed from the 5% LDRRM Fund in the amount of P158,470.00, is based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and

4. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01, S-2023 dated April 27, 2023.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Lingayen, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Sb Resolution No. 373, S-2023 of the Sangguniang Bayan of Lingayen, Pangasinan, entitled “Approving Supplemental Investment Program (SIP) No. 1, CY 2023 of the Municipality of Lingayen, Pangasinan”;
