RESOLUTION NO. 559-2023

APPROVING RESOLUTION NO. 49-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2023 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its SB Resolution No. 49-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Disaster Risk Reduction Management Council, through MDRRM Council Resolution No. 01, Series of 2023, prepared the revised LDRRMP Investment Plan to utilize the Unexpanded Balances of LDRRM Fund (CYs 2019-2022) of the LGU;
2. This was integrated in the Revised AIP for CY 2023 and was endorsed by the Municipal Development Council of Urbiztondo, Pangasinan through MDC Resolution No. 01 S' 2023 dated March 16, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

3. The LGU revised their AIP for CY 2023 to include new projects to be funded from the 5% Local Disaster Risk Reduction Management Fund (LDRRMF) Unexpended Balances from CYs 2019, 2020, 2021, and 2022 amounting to a total of P6,302,626.83; and
4. The preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013, to quote:

Section 6.4 The unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the Local Disaster Risk Reduction and Management Council (LDRRMC) within the next five (5) years.

Section 6.5 The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the Local Sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Sb Resolution No. 49-2023 of the Sangguniang Bayan of Urbiztondo, Pangasinan, entitled “Approving the Revised Annual Investment Program (AIP) for CY 2023 of the Municipality of Urbiztondo, Pangasinan”;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Urbiztondo, Pangasinan, for its information and guidance.
