RESOLUTION NO. 560-2023

APPROVING RESOLUTION NO. 76-2023 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CY 2023 OF THE MUNICIPALITY OF NATIVIDAD, PANGASINAN AMOUNTING TO TWENTY FOUR MILLION SEVENTEEN THOUSAND NINE HUNDRED EIGHTY NINE PESOS AND NINETY EIGHT CENTAVOS (P24,017,989.98)”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its SB Resolution No. 76-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of Natividad, Pangasinan has identified items in their Supplemental Annual Investment Program No.01 for CY 2023. This was endorsed to the Sangguniang Bayan on April 27, 2023 through MDC Resolution No.01-2023;

2. The SAIP No. 01 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some offices in the LGU and for the implementation of Community Development and Disaster Risk Reduction Programs of LGU Natividad;
3. Funding support for the proposed SAIP No.01, with a total investment requirement of PhP24,017, 989.98 is embodied in the municipality's Supplemental Budget No. 01-2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No.01-2023 on May 15, 2023.




