**RESOLUTION NO. 563-2023**

**DECLARING ORDINANCE NO. 138, S-2022, OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED "AMENDING THE TITLE, CHAPTER II SECTION 5 AND 6, AND CHAPTER III SECTION 9 OF MUNICIPAL ORDINANCE NO. 88, S-2020 ENTITLED "REQUIRING THE MANDATORY USE OF FACE MASKS AND STRINGENT PRACTICE OF PHYSICAL DISTANCING BY ALL PERSONS WHO ARE FOUND IN THE MUNICIPALITY OF SAN NICOLAS DURING THE EXTREME ENHANCED COMMUNITY QUARANTINE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 138, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iii) of R.A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Section 59 & 511 (a) of R. A. No. 7160;
