## RESOLUTION NO. 566-2023

DECLARING ORDINANCE NO. 2023-013, OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE TO PREPARE FOR AND RESPOND TO THE IMPACTS OF EL NINO IN TAYUG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-013 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (1) (iv) of R. A. No. 7160 and the Department of the Interior and Local Government Memorandum Circular No. 2023-065, entitled "Mitigation and Preparedness Measures for the El Nino Phenomenon 2023;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
