PROVINCIAL RESOLUTION NO. 569-2023

**ENDORISING TO THE DEPARTMENT OF HEALTH THE
APPLICATION FOR A LICENSE TO OPERATE A 100-BED
CAPACITY OF THE LINGAYEN DISTRICT HOSPITAL,
PROVINCE OF PANGASINAN**

WHEREAS, the Lingayen District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, along with the Mangatarem District Hospital, caters to patients coming from the different municipalities and other areas from nearby localities of the 2nd District of Pangasinan;

WHEREAS, the Lingayen District Hospital intends to increase its bed capacity from 40 to 100 or an increase of 150% in authorized bed capacity;

WHEREAS, due to the improvement and rehabilitation work done in the Hospital, it has recorded a significant increase in the number of patients who preferred to come to the hospital thereby its authorized bed occupancy has been exceeded;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Lingayen District Hospital to provide a sufficient and higher level of medical and health services to its patients by increasing its bed capacity from 40 to 100;

WHEREAS, prior to the issuance of a license to operate, a Provincial Board Resolution is required by the Department of Health to facilitate the issuance of the permit to construct or upgrade a health facility;
