DECLARING ORDINANCE NO. 2023-14 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN AND CREATING THE FOLLOWING STAFF COMPLEMENT: CITY GOVERNMENT DEPARTMENT HEAD (PESO MANAGER) AND ADMINISTRATIVE ASSISTANT II (CLERK IV)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
