RESOLUTION NO. 571-2023

DECLARING ORDINANCE NO. 2023-15 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE ALAMINOS CITY COLLEGE IN THE CITY OF ALAMINOS, PANGASINAN, DEFINING ITS MANDATE AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-15 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iv), 76 & 458 (a) (5) (x) of R. A. No. 7160;

WHEREAS, the local government unit should provide the specific account to draw the fund to carry out the implementation of this ordinance, so as not to affect appropriations which are already allocated to specific PPAs of the local government unit;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


