RESOLUTION NO. 573-2023

DECLARING ORDINANCE NO. 2023-17 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF DISABILITY AFFAIRS OFFICER IV, SG-22/1 UNDER THE OFFICE OF PERSONS WITH DISABILITY AFFAIRS OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
