RESOLUTION NO. 574-2023

APPROVING SB RESOLUTION NO. 40, S-2023 OF THE SANGGUNANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 01 CY 2023 OF THE MUNICIPALITY OF BANI, PANGASINAN INVOLVING AN AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) TO BE FUNDED THROUGH A BANK LOAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 40, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Supplemental Investment Program (SIP) No.1 was endorsed by the Municipal Development Council to the Sangguniang Bayan for approval on April 27, 2023 thru MDC Resolution No. 2023-01. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;
2. Said SIP No. 1 covers fund augmentation for the implementation of various programs/projects of some municipal government offices, which will be funded out of the LGU's loan proceeds from the Land Bank of the Philippines;

3. Funding requirement for the implementation of such, amounting to Php150,000,000.00, is embodied in the municipality's Supplemental Budget No.1 CY 2023, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01- s.2023 on May 22,2023 and approved by the Acting Municipal Mayor on May 24, 2023; and
4. With regards to the Municipal Ordinance No. 06-s.2023, the programs/projects covered by the loan agreement between LGU-Bani and the Land Bank of the Philippines are integrated in and consistent with the above-subject SIP No.1 CY 2023 of the LGU.



RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 40, Series of 2023 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 01 CY 2023 of the Municipality of Bani, Pangasinan involving an amount of One Hundred Fifty Million Pesos (P150,000,000.00) to be funded through a bank loan";
