DECLARING MUNICIPAL ORDINANCE NO. 06, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE LGU-BANI REPRESENTED BY ITS HON. MAYOR FACUNDO PALAFOX, JR. AND THE LAND BANK OF THE PHILIPPINES, REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, CESAR N. ULPINDO, IN THE AMOUNT ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) TO FUND THE ACQUISITION OF LOT AND CONSTRUCTION OF A NEW PUBLIC MARKET WITH INTEGRATED TRANSPORT TERMINAL AND OTHER FACILITIES, AND LAND ACQUISITION AND DEVELOPMENT OF THE BANI SANITARY LANDFILL, AND PROCUREMENT OF HEAVY EQUIPMENT INCLUDED IN THE APPROVED SUPPLEMENTAL INVESTMENT PROGRAM NO. 01 CY 2023 MUNICIPALITY OF BANI, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 06, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297 (a) (b) (c), 444 (1) (vi), 447 (a) (2) (iii) (iv) of the Local Government Code of 1991 and Article 417 (a) of the Implementing Rules and Regulations of the said Code;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 06, S-2023 of the Sangguniang Bayan of Bani, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the LGU-Bani represented by its Hon. Mayor Facundo Palafox, Jr. and the Land Bank of the Philippines, represented by its Assistant Vice President/Head, Pangasinan Lending Center, Cesar N. Ulpindo, in the amount One Hundred Fifty Million Pesos (P150,000,000.00) to fund the acquisition of lot and construction of a new public market with integrated transport terminal and other facilities, and land acquisition and development of the Bani Sanitary Landfill, and procurement of heavy equipment included in the approved Supplemental Investment Program No. 01 CY 2023 Municipality of Bani, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bani, Pangasinan, for its information and guidance.
