RESOLUTION NO. 580-2023

DECLARING MUNICIPAL ORDINANCE NO. 8, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “AN ORDINANCE CREATING SIXTEEN (16) PLANTILLA POSITIONS IN THE MUNICIPALITY OF MABINI, PANGASINAN AND APPROPRIATING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 8, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R. A. No. 7160;

WHEREAS, the parenthetical position title of Administrative Aide III, Salary Grade 3 under the Mayor and Vice-Mayor’s Office should be amended from Driver and Co-terminous Driver, respectively to Driver I to conform with the Index of Occupational Services, Position Titles and Salary Grades for Local Government (IOS-LGU), Calendar Year 2021 Edition;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


