RESOLUTION NO. 583-2023

DECLARING ORDINANCE NO. 009, S-2023 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING A VOLUNTARY BLOOD DONATION PROGRAM IN THE MUNICIPALITY OF LINGAYEN TO BE KNOWN AS "DUGO MO, DUGTONG NG BUHAY KO", CREATING THE MUNICIPAL BLOOD COUNCIL, AND APPROPRIATING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Municipal Ordinance No. 009, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 7719, otherwise known as "The National Blood Services Act of 1994; and Sections 16, 17 (b) (2) (iii) and 447 (a) (2) (i) of R. A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


