PROVINCIAL RESOLUTION NO. 587-2023

REQUESTING THE SECRETARY OF THE DEPARTMENT OF JUSTICE THROUGH THE LAND REGISTRATION AUTHORITY ADMINISTRATOR TO INCLUDE ALL THE OTHER FIVE (5) MUNICIPALITIES OF THE 3RD DISTRICT OF PANGASINAN IN THE JURISDICTION OF THE REGISTER OF DEEDS IN THE CITY OF SAN CARLOS, PANGASINAN

WHEREAS, there are now a number of Register of Deeds in the Province of Pangasinan, particularly in Alaminos City (1st District), Lingayen (2nd District), San Carlos City (3rd District), Dagupan City (4th District), Urdaneta City (5th District) and Tayug (6th District);

WHEREAS, the 3rd District of Pangasinan comprises other five (5) municipalities namely: Calasiao, Sta. Barbara, Mapandan, Malasiqui and Bayambang;

WHEREAS, the inclusion of the other municipalities of the 3rd District in the jurisdiction of the Register of Deeds in the City of San Carlos would be more beneficial to the people in terms of a more expeditious, economical and convenient way of service;

WHEREAS, the Register of Deeds in the City of San Carlos will help decongest the heavy volume of land transactions and related businesses in the other Registers of Deeds of the Province particularly in Lingayen, Pangasinan;

WHEREAS, the Sangguniang Panlalawigan fully supports the expansion of jurisdiction and extension of services of the Register of Deeds in the City of San Carlos as it will foster faster delivery of public service to the people of Pangasinan;
